Background

ECP-2 is the second stage of the CRU's development of enduring connection policy in Ireland. On the 10th June 2020 the CRU published their decision on ECP-2, which set policy for at least three annual batches of connection offers (ECP 2.1, ECP-2.2, and ECP-2.3).

ESB Networks have used the ECP-2 decision paper¹ and subsequent ruleset² to determine which Category B and Category C applicants have been successful in making the list of projects due to receive connection offers in the ECP-2.3 Batch.

This report contains the list of ECP-2.3 applicants processed under Category B and Category C as per the ECP-2 Decision Paper.

The CRU has decided that for ECP-2, there should be a possible connection pathway for specific sub-categories of projects to be connected outside the framework of the batch process.

The non-batch category B was open to the following projects:

- Small projects i.e. MEC greater than 6kW/11kW and less than or equal to 500kW
- DS3 system services trial projects up to 500kW; and
- Autoproducers

The non-batch category C was open to the following projects:

• 100% community- owned projects where MEC greater than 0.5MW and less than or equal to 5MW
