#### The CRU has issued its PR6 Draft Determination, and a consultation is now underway

ESB Networks submitted its PR6 Business Plan to the CRU in Q4 2024 outlining our investment plan for the network for the period 2026 to 2030. The document can be found at ESB Networks Price Review 6 Business Plan.

In early July, the CRU issued their Draft Determination through which they evaluate and approve the proposed investment plans submitted by the network companies, ESB Networks and EirGrid. The CRU has opened a consultation on the Draft Determination and responses should be submitted via their consultation platform by the close of business on 11 September 2025.

The ESB Networks' 'Stakeholder Engagement Report 2024' consultation, which highlighted how ESB Networks collaborated and engaged with our stakeholders and customers over the course of 2024, was published for consultation earlier this year with a closing date of 2 May.

The report outlined a high level range of activities carried out by ESB Networks to engage with stakeholders (consultations, publications, meetings, forums, working groups, and events) over 2024 and how feedback received helped to shape and modify relevant work programmes and initiatives.

## ESB Networks publishes the Distribution Network Development Plan (DNDP) and opens consultation process

In our Networks for Net Zero Strategy, ESB Networks has committed to delivering a net zero ready electricity distribution network by 2040, to enable Ireland to achieve its net zero goals by 2050. A key action in the Strategy is to publish a Ten-Year Distribution Network Development Plan (DNDP) as required under the Clean Energy Package Directive (EU) 2019/944. The DNDP sets out our planned investments in network infrastructure over the medium and long term and indicates flexibility needs in each area.

The Distribution Network Development Plan (DNDP) Summary Document and Methodology Statement and the Distribution Network Development Report are published on our website for consultation <a href="mailto:here">here</a>. We welcome all stakeholder feedback and input, particularly on whether our approach meets stakeholder requirements. Stakeholder feedback is vital as it will help shape the final Distribution Network Development Plan which will be published by the end of 2025.

Focusing on the theme "Powering the Energy Transition to Net Zero, from Pilot to Scale", the Smart Grid Ireland Innovation Conference on 18 June highlighted innovations bridging policy, regulation, and delivery gaps.

In the panel discussion, 'Future power: Developing the national grid to meet future demand', Emma Silke, Electrification Manager, ESB Networks, Aoife O'Grady, Head of Zero Emission

Vehicles Ireland, Department of Transport, Dr. Eva Barrett, Director of Policy and Regulation, Irish Solar Energy Association, and Justin Moran, Director of External Affairs, Wind Energy Ireland discussed the critical role of the electricity network in supporting climate goals, and the importance of cross industry collaboration in developing the national network to meet future demand.

This April saw the all-time highest amount of monthly generation from solar farms in Ireland (according to Irish Grid Monthly's real-time solar estimation model, which measures utility-scale solar farm output). To mark this milestone Aidan Kelliher, Renewables and Major Connections Manager, ESB Networks and Network Technicians Neil O'Neill and Karen Griffin, visited one of our customers, Power Capital Renewable Energy, at their 84 MW Solar PV farm at Tullabeg in County Wexford. 
